The Commission also advised that the provision of Biometric attendance in Educational Institution should also be made liberal due to poor internet connectivity in the Tribal areas. It is also recommended that atleast one Post Matric/College for Tribal girls may be set up in each District Headquarter to facilitate proper education for them. Keeping in view the inadequacy of Tribal hostel, it was also suggested that hostel rent may be paid to the Tribal students who could not be allotted hostel accommodation, as being done in the schemes run by the Government of Madhya Pradesh.




